## WHAT IS THE EXPORT MARKET DEVELOPMENT GRANT (EMDG)?

The Export Market Development Grants (Emdg) Scheme is a Key Australian Government Financial assistance program for small to medium aspiring and growing export-ready businesses. It encourages business to increase international marketing and proportion expenditure to achieve more sustainable international sales

The program is designed to bring benifits to Australia by encouragin the creation, development and expansion of foreign markets markets for Australian products. The new EMDG program now provides upfront funding certainty so you know how much you will receive over the life of your grant agreement (2 or 3 years). The grant covers 50% of eligible marketing expenses with the maximum grant being between \$40,000 and \$150,000 per annum depending on the tier you qualify for.
