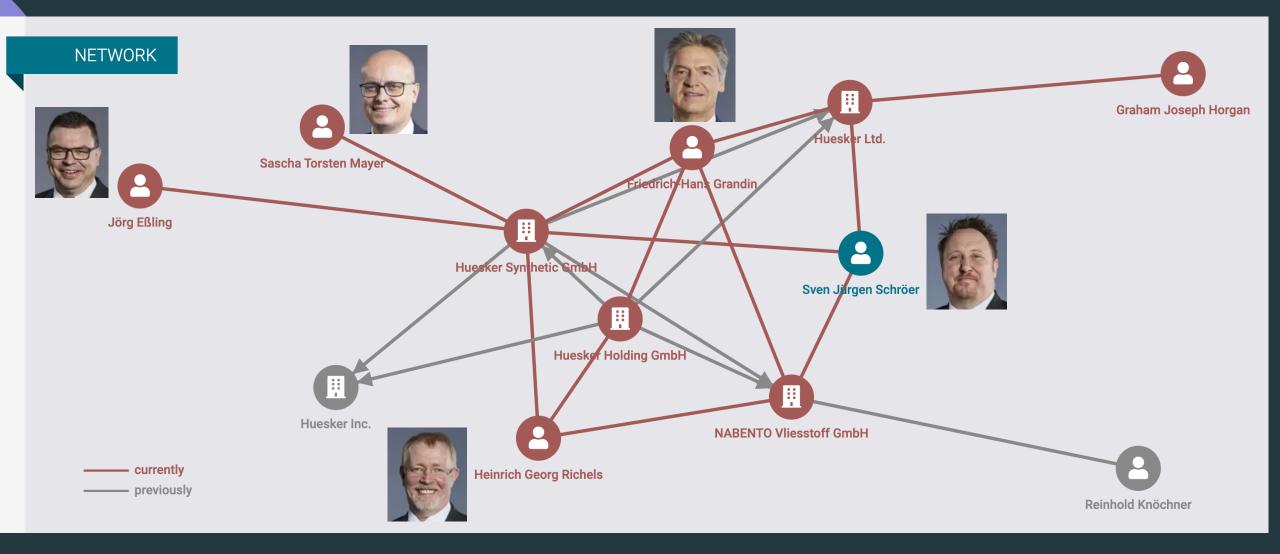








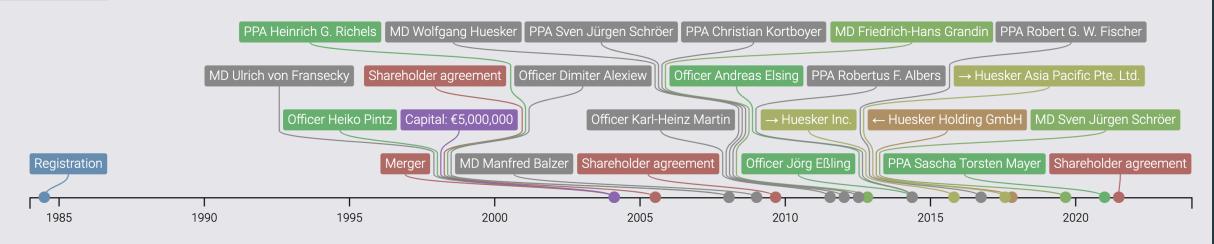




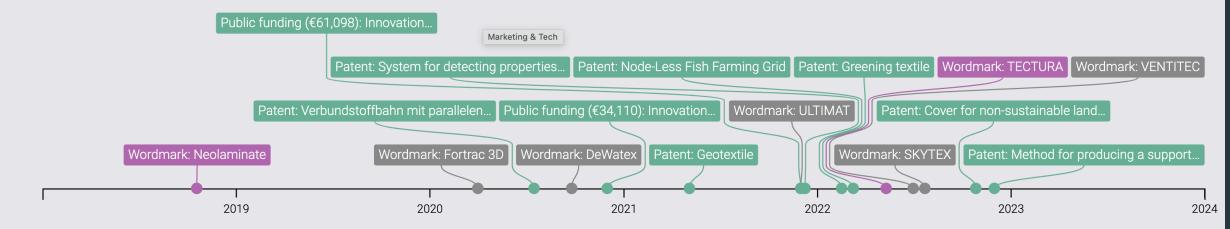




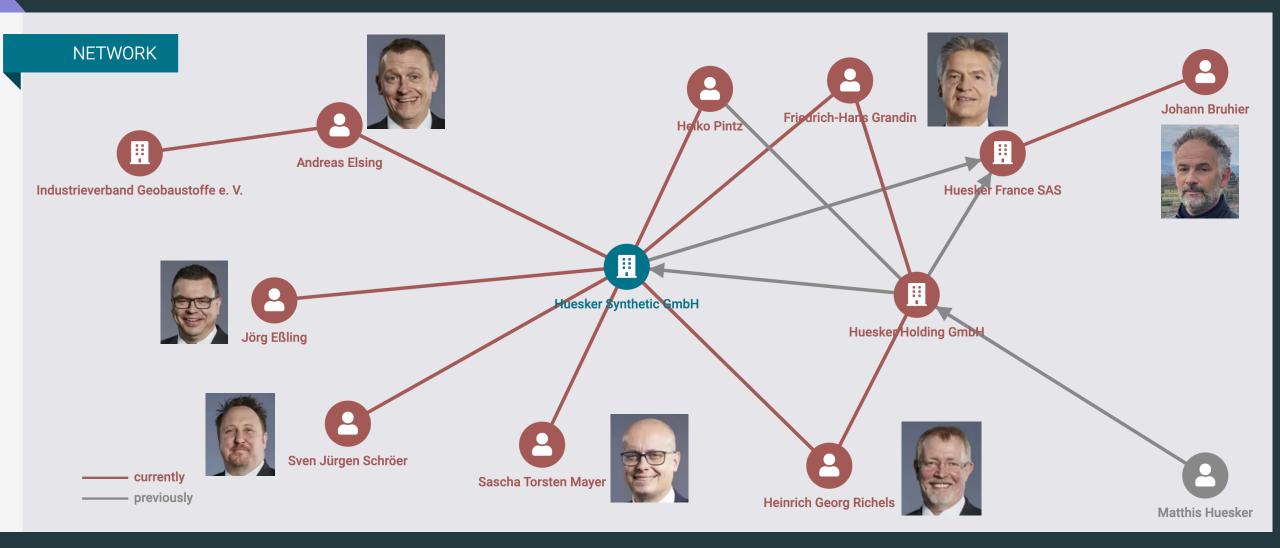
# **HUESKER Company History Timeline**

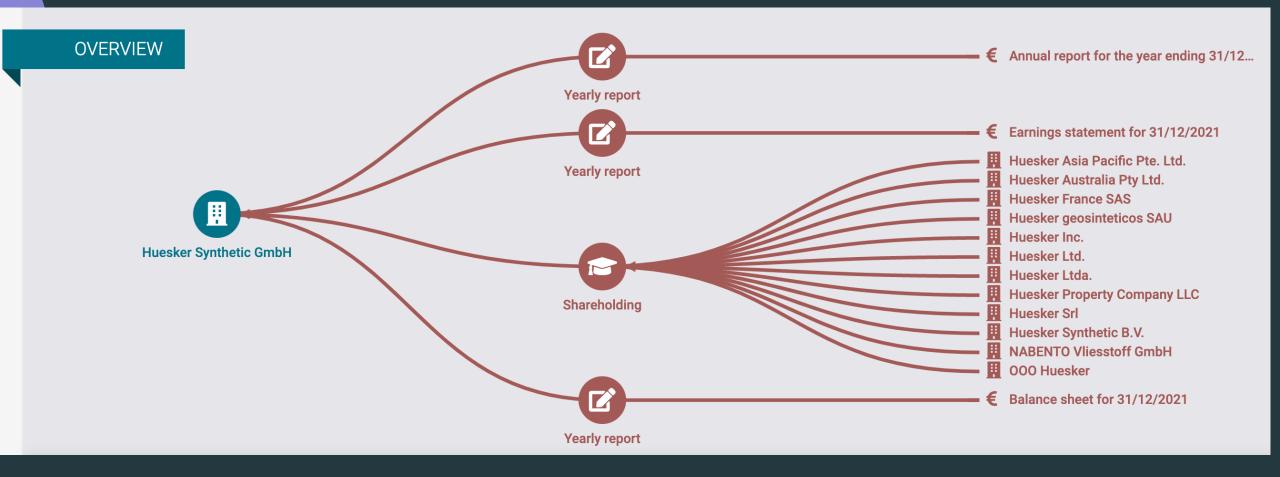
